Dear Brothers:

By means of this letter we are transferring the Publisher Record Card for [REDACTED]. We know that [REDACTED] is no stranger to you brothers since he was associated with your congregation prior to coming to us (see your letter of introduction of October 10, 2002 to us).

As you know [REDACTED] had been disfellowshipped and was reinstated on August 7, 2004. He is under full restrictions which you brothers can lift as you see fit. We do not believe we need to say much regarding [REDACTED] and the details surrounding his disfellowshipping since Brother [REDACTED] was a member of both the disfellowshipping and reinstatement committees. We will formally inform you that [REDACTED] has been accused of child abuse including sexual abuse of his two daughters.

We would like to provide you with some addition information that has come to our attention:

- (1) Based on a letter from the Christian Congregation of Jehovah's Witnesses and discussions with Brother [REDACTED] we understand that you have received a new accusation charging Brother [REDACTED] with child sexual abuse from the Fort Kent, Maine Congregation

The Christian Congregation has requested "two elders to meet with him and have him go on record with the congregation regarding this allegation."

- (2) Brother [REDACTED], our former presiding overseer, was called by [REDACTED] the presiding overseer from the Westfield East Congregation, stating that [REDACTED] has sent them a letter charging [REDACTED] with slander. According to Brother [REDACTED] claims that [REDACTED] has called the non-witness daughter of [REDACTED] fiancé, [REDACTED] and has attempted to poison [REDACTED] relationship with [REDACTED]. We have had some concerns regarding [REDACTED] seeming obsession in filing charges against [REDACTED] from the start of the long ongoing investigation into this matter.

Please note that [REDACTED] is the daughter of [REDACTED] of the Fort Kent, Maine Congregation.

We hope that the above information will prove helpful to you brothers as you care for the sheep that our Lord and Savior has placed under your oversight. We are copying the Christian

Congregation of Jehovah's Witnesses so that they will be aware that [REDACTED] is now associated with your congregation. In communicating with them you will need to let them know of their current reference and letter dates are: SDV:SSN (06-22-04, 08-31-04). Note that the previous references with letter dates were: SDK:SSH – (11-28-96, 01-14-97, 11-11-99, 11-18-99); SDK:SSM – 10-21-99; SDK:SSW – 12-23-99; SDK:SSA – (01-20-00, 03-27-00). This information may be helpful to the brothers at the Christian Congregation of Jehovah's Witnesses.
