Dear Brothers

I am begging you to hear a story about a brother who has been slandered not once but several times over the years by a daughter, [REDACTED]. Yes, she uses her warriors; she doesn't want any direct confrontation. In this case most recently [REDACTED] and before that her sister [REDACTED].

While in Fort Kent, Maine I was deleted as an elder, the brothers were uncomfortable with me. That's the reason Brother [REDACTED] gave me. My daughter had influenced the brothers negatively.

My daughter, [REDACTED] had told them that I was abusing her physically though I was not aware of these accusations. Why because she no doubt told them never to bring it up to me and gave them her reason to them.

Why can I assume this, well in 1988 [REDACTED] who had been giving me a hard time, not wanting to eat with us, being uncooperative in the Family study etc. [REDACTED] had gone through a terrible transformation once she started working at the age of 16, and also because of her association with [REDACTED].

I tried to break up her association with [REDACTED] but her father, [REDACTED] was the presiding overseer and I was a ministerial servant. He told me that until [REDACTED] had never done well spiritually so my goose was cooked as Brother [REDACTED] had a severe personality conflict openly never liked me and once in front of the entire congregation corrected me. I could tell of other occasions but won't.

In 1988 my wife [REDACTED], now deceased, went to pioneer school. [REDACTED] was feeding [REDACTED] stories that were completely false, so it was [REDACTED] who told her to put a tape recorder under her bed and get me to show my true colors. She, [REDACTED] tried to provoke me into doing something bad. It never happened so it was never used then, but surfaced 15 years later.

Why because I had lost my wife [REDACTED] after taking care of her for 8 years, [REDACTED] never offered any help and only saw [REDACTED] 3 times, the last was 2 months before [REDACTED] died. [REDACTED] has been an awful daughter to me.

A year after [REDACTED]'s death, [REDACTED] and [REDACTED] heard that [REDACTED] and I was very happy and was engaged to marry.

[REDACTED] used the tape recorder incident to try to break us up. [REDACTED] came up to [REDACTED] at the Natick Hall in 2003, she even brought a witness, and said a lot of things about me and that [REDACTED] should be afraid of me and [REDACTED] should break up with me because if she had heard the tape she'd see

how bad I was. She did this with me present. When I walked away she was glaring at me all the while words were exchanged. She also told us that she was the one that told [redacted] to put the recorder under the bed. What [redacted] and [redacted] did the world calls entrapment. Even the world frowns on it.

What were the results of the tape recorder incident? [redacted] told [redacted] [redacted] would be happy to let her hear it. Guess what happened when [redacted] called back she told [redacted] that she no longer had it and yet [redacted] made it appear as though she'd just heard it. So [redacted] used pioneer school with [redacted]'s absence to smear me in 1988 and was now using it.

When this failed to convince [redacted] to break up with me, [redacted] daughter, who is not in the Truth, had a visit from a sister, [redacted], who told the story that I was a child abuser, this caused [redacted] much chagrin as she had a daughter. [redacted] told her not let her be alone in a room with me. Needless to say this has really hurt the relationship between [redacted] and her mother, at one time was very close.

Since then both of the [redacted]'s told the report to their C.O., Brother [redacted]. They heard it from their daughter [redacted]. When asked more questions [redacted] said that she was told of information by [redacted] while she was getting a massage. To me this is slander.

After these things failed [redacted] brought up charges of my raping her repeatedly while she was a young girl. These charges she had brought up in 1999 and withdrew them because she told [redacted] she was afraid of me. [redacted] was told not to tell me. Then brought up charges again in 2003 this was the first I'd heard of them. Charges again were brought against me in October of 2004.

When [redacted]'s charges were revisited of my examining her in 1974 at the request of her mother. I was stupid enough to do it. The brothers looked upon it as sexual abuse. Never did I do anymore than examine her but still I know that I should never have done it. I also spanked her severely at times and am sorry for my actions.

The brother's said [redacted] horrendous charges didn't affect their decision but I know that it did. I told them at that time and continue to say the same thing that [redacted] charges are out and out lies.

After I was disfellowshipped, [redacted] now brought me to court because she could bring charges against me with a restraining order, I was no longer a brother. Since her alleged charges took place in East Hartford Conn. The police came to my house to interview me. I gave them one name of a brother, [redacted], who had lived with us in East Hartford for almost one year. Unfortunately for [redacted] this is a brother who saw her mother as a very violent person also [redacted] as a deceptive and less than truthful. Also

for lack of any evidence how can they prove lies. The East Hartford police never followed up on [REDACTED] accusations. [REDACTED] told the brothers recently in Palmer it was because of the statute of limitations but as with all of [REDACTED] lies this is another one. Connecticut doesn't have a statute of limitation on sexual abuse or child abuse cases.

Incidentally my former wife, [REDACTED], was disfellowshipped for fits of anger for 11 years. [REDACTED] continued to have contact with her all the while though I tried to discourage her to do this. Coincidentally my problems began when she was reinstated in 1997.

[REDACTED] has told the brothers so many lies and Natick incident is just another one.

I went to my Natick assembly without knowing that [REDACTED] and [REDACTED] would be there. They had called [REDACTED], [REDACTED] called me and asked if I was going to the assembly then called them back and told them that I was going. They never let us know that they would be there.

Well I'm at Natick and all of a sudden [REDACTED] comes up to me, I was at the extreme corner in the rear of the hall, away from anyone. [REDACTED] told me that someone was outside to see me, and that he had nothing to do with it. Four policemen were outside of the hall they hand cuffed me and brought me to jail for breaking the restraining order. Only later I found out what had happened. [REDACTED] approached [REDACTED] and said they were at the assembly and because of a restraining order I was breaking it even though I was unaware of their presence. [REDACTED] said he would go and tell me and I would leave but [REDACTED] would have none of that. So some time later the police came and even entered the Hall with weapons drawn.

I heard that the District overseer was very upset and so were others, but no one really wanted to find out the truth. [REDACTED] and [REDACTED] may have told a distorted story to the brothers in West Springfield congregation and because of lack of interest in the truth even the C.O. thought the case was resolved.

The truth was that they told an outright lie. They said they approached me and they told me they were there and the police came 20 minutes later. Complete falsehood, which was told to all and even the District Attorney.

When the case came up, the District Attorney talked to [REDACTED] he realized that he didn't have a case, and the charges were dismissed by the judge. Everyone was mad about something, the judge for wasting time of the court and the District Attorney for the story told by [REDACTED] and [REDACTED] I was told that the District Attorney said it was entrapment.

Brother I have been slandered so much that I have trouble comprehending why nothing has been done as slander has been likened to murder and they, [REDACTED] and [REDACTED] have done just that. They have in deed ruined my name.

[REDACTED] also had a part in bringing falsehoods to [REDACTED] daughter in August of 2004. [REDACTED] called personally to tell her that [REDACTED] restraining order was not the only one that was brought against me. Told other stories, like I took [REDACTED] out in the field and cut of f the dolls head arms and legs and said to [REDACTED] something similar would happen to her. There was never any other restraining order against me I would have had to be advised about it and brought to court yet this never happened.

I brought this information to [REDACTED]'s overseer, Brother [REDACTED] of Westfield. He never acted upon them, why, I don't know he received a complete report 9/10/04. I also told [REDACTED] about another incident about [REDACTED] abused [REDACTED] verbally while she was in the lady's room of the court house, [REDACTED] was afraid that she would abuse her physically.

I told Brother [REDACTED] to call [REDACTED] and [REDACTED] he never did. It was as though he, too didn't want to have the complete truth.

Now I count at least 4 time [REDACTED] has had occasions where she slandered me stories of [REDACTED] also three times [REDACTED] has charged me with sexual abuse.

Now you have heard of the latest incident. The Flyers that were sent out around the park where I live, and who knows where else. Now Jehovah's name has been pulled into the mud.

I really feel if something had been done before about all this information, this wouldn't have taken place.

If you should hear [REDACTED] story about my raping her, and others raping her etc. And talk to me you are going to see the obviousness of who is telling the truth. I have never had this chance. [REDACTED] knows this.

Please brother use Jehovah's Holy Spirit in this matter and the truth will be revealed plainly to you I promise and would guarantee it.
